## Many reasons to be proud you are a member of NHTC

We appreciate all of the positive comments we are hearing from so many satisfied customers. We want to enjoy and participate in your successes.

As we approach the Annual Meeting, it is my privilege to address some of the great advantages of participating in our cooperative. The advantage that seems to be the most near and dear to everyone this time of year is the opportunity to reap the benefits of ownership. Again this year, active members will receive a check in early to mid-May, refunding 2% of their accumulated equity. NHTC is one of only three telephone cooperatives in the state, so most of our fellow Alabamians do not enjoy a return on their use of telecommunications services. We must realize other types of cooperatives have never been so fortunate to return portions of their members' equity.

In deciding on a refund (and if so, what percentage) the directors annually face the challenging task of analyzing requirements placed on us by Rural Utilities Service, Federal Communications Commission, Alabama Public Service Commission and the pressures exerted on us by the industry's progressive competition and technology. Sure, they would love to give back lots of money each year. However, it is their fiduciary responsibility to make a sound decision for the Cooperative as a whole, both now and down the road. With increasing industry and economic challenges, capital credit refunds may or may not be made in the future.

Not only do we enjoy the capital refunds when they are available, we can join in the pride that is felt, knowing our cooperative has an outstanding response time for installation and a 'second-to-none' response time on service restoration. Thanks to con-

tinually updating and maintaining our plant, we are fortunate to experience much fewer outages than many in our industry. Of the service interruptions we experience, 99% of our telephone service restorations are within 24 hours of receiving the reported outage, 90% - 95% are within 8 hours, and many within 2-4 hours.

Your cooperative is also outperforming those known as 'industry leaders' in areas of new technology. It is an amazing accomplishment to be able to provide broadband service to any customer in the most remote parts of our service area. In Alabama, Bell-South can only provide DSL to 45% of their customers and have a target of reaching 65% deployment by 2007. We are moving forward and have great expectations for sharing even more accomplishments as we progress. These are a few of the reasons you can join me in saying "I'm proud to be a member of NHTC!"

I'm looking forward to joining you at the 2005 NHTC Annual Members' Meeting at 7:30 pm, May 17th, in the New Hope Elementary/Middle School Auditorium. Please come early to register and enjoy the entertainment that will be provided.

#### **Excerpts from Bylaws on Voting Procedure to Elect Board Members**

Article IV Board Members

Section 1. *General Powers*. The business and affairs of the Cooperative shall be managed by a board of directors, consisting of nine (9) members. The membership of the Board of Directors shall be based as follows:

New Hope, four (4) members on the Board of Directors; Owens Cross Roads, two (2) members on the Board of Directors; and Grant, three (3) members on the Board of Directors.

Section 2. Election and Tenure of Office. The persons presently serving as directors of the cooperative shall compose the Board until the first annual meeting or until their successors shall be elected by a secret ballot at each annual meeting of the members, beginning with the year 1984 by and from the members at large to serve until the next annual meeting of the members or until their successors shall have been elected and shall have qualified. If an election of directors shall not be held on the day designated herein for the annual meeting, or at any adjournment thereof, a special meeting of the members shall be held for the purpose of electing directors within a reasonable time thereafter. Directors may be elected by a plurality vote of the members. All elected directors shall serve a term of four (4) years provided they do not resign or are not removed from office by the members. All directors terms will be staggered so that two (2) are elected each year, except in 1987 three (3) members of the Board of Directors shall be elected and every four (4) years thereafter; i.e., 1991,1995, etc., three (3) members of the Board of Directors shall be elected.

Section 3. Qualifications. No per-

son shall be eligible to become or remain a board member of the cooperative who:

- a) Is not a member of the Cooperative: and
- b) Is not a bona fide resident of the respective exchange from which said Board member was elected.
- c) Is in any way employed by or financially interested in a competing enterprise or a business engaged in selling or reselling telephone service or supplies, or constructing or maintaining telephone facilities, other than a business operating on a cooperative nonprofit basis for the purpose of furthering rural telephony.

Upon establishment of the fact that a board member is holding the office in violation of any of the foregoing provisions, the board shall remove such board member from office.

Nothing contained in this section shall affect in any manner whatsoever the validity of any action taken at any meeting of the board.

Section 4. Nominations. It shall be the duty of the board to appoint, not less than thirty (30) days nor more than seventy five (75) days before the date of a meeting of the members at which board members are to be elected, a three member (3) committee on nominations consisting of one (1) member from each exchange, so as to insure equitable representation. No member of the board may serve on such committee. The committee keeping in mind the principle of equitable representation, shall prepare and post at the principle office of the Cooperative at least twenty (20) days before the meeting a list of nominations for board members which shall include

at least two candidates for each board position to be filled by the election. The Secretary shall be responsible for mailing with the notice of the meeting or separately, but at least ten (10) days before the date of the meeting, a statement of the number of board members to be elected and the names and addresses of the candidates nominated by the committee on nominations. Any fifty (50) or more members acting together may make other nominations by petition and the Secretary shall post such nominations at the same place where the list of nominations made by the committee is posted. Nominations made by petition, if any, received at least five (5) days before the meeting shall be included on the official ballot. Later nominations by petition shall be treated as nominations from the floor. The chairman shall call for additional nominations from the floor and nominations shall not be closed until at least one minute has passed during which no additional nominations has been made. No member may nominate more than one candidate, for the same position.

Any nominee by petition or from the floor must meet the qualifications stated in the Bylaws, Article IV, Section 3.

Section 5. Failure of Action by the Nominating Committee. In the event the nominating committee fails to make a report after 3 requests by the Secretary and having been notified and appointed in accordance with the Bylaws Article IV Section 4, it shall be the duty of the Board of Directors to make said nominations or nominations based upon the guidelines set out in the Bylaws, Article IV, Sections 1 through 4.

# What's so special about a cooperative?

The first American cooperative was established by Ben Franklin in 1752 to bring affordable goods and services to those who did not have



access to them. That is exactly what local citizens, including the New Hope Lions Club, did for us in the early 50's.

Service providers, at that

time, offered telephone services only in densely populated metropolitan areas, where they could make a nice profit. Our very own 'Ben Franklins' established our cooperative to provide communications services for our small towns and rural areas. At NHTC we still value the privilege of providing services to our members in rural areas.

The basic principles of the Cooperative form of business are:

- 1) Anyone who can use the services of a cooperative and is willing to accept the responsibilities of membership is eligible to join
- 2) Power is shared equally among all members, via electing a board of directors and, when necessary, voting on specific issues
- 3) Provide a service to its members (not to make a profit)
- 4) Return margins above and beyond the costs required to cover the operating expenses.

# Capital credit checks to be mailed soon

The Board of Directors for New Hope Telephone Cooperative recently approved a two percent (2%) refund of capital credits for all active members. These refunds will represent 2% of the total capital credits each member has accumulated to date, less any refunds already given.

This is another example of the benefit of a cooperative, Board members stated. The profits of New Hope Telephone are not sent to out-of-town investors; rather, they remain in the communities that are served by the cooperative.

"I'm sure each of you will be looking forward to receiving your check, I know I am," stated NHTC General Manager Teresa Hunkapiller. "This is the only time each year that I receive a check from a company instead of mailing them one." The refund checks are scheduled to be mailed to members the first week in May.

#### A note to our wonderful members

Our sincere appreciation goes out to those customers who have attempted to have us bill their DSL modem purchase on a 3-month payment plan. Your patience has been wonderful as you have shared our experiences in stretching the limits of a 15-year-old software package. We appreciate your understanding, and hope you can appreciate our determination to use our existing resources in order to offer you as many options as possible. We are actively analyzing software options and plan a migration in late 2005 or early 2006.

## New pricing for PIC change

Effective April 29, 2005, the charge for you to change your long distance service provider, commonly referred to as a presubscribed primary interexchange carrier (PIC), will increase from \$5.00 to \$5.50. The PIC Change Charge recovers the costs to manually process your change in long distance service provider. This increase is a result of new pricing regulations put in place by the Federal Communications Commission (FCC).

## A message from The C.A.R.E. Center HEALS clinic to open in New Hope

Healthcare is largely unavailable in the rural, low-income communities of eastern Madison County. On the property of New Hope Elementary rests a dilapidated single-wide trailer that will soon become the New Hope HEALS Clinic, with your help.

This clinic will serve over 2,400 students from New
Hope Elementary, New Hope
High School, Madison County Elementary, Madison County High School and Owens Cross Roads Elementary.

This urgent endeavor is a collaborative effort of volunteers, local churches

- Diagnosis and treatment of acute and chronic illnesses
- Immunizations
- Laboratory testing and services
- Sport and school physicals
- Vision and hearing screenings
- Social work services
- Health education
- Injury prevention
- Referrals for other specialty services

and businesses, along with HEALS, The C.A.R.E. Center, and Leadership Huntsville/Madison County.

The total project is projected to cost upwards of \$175,000. The renovation of the structure itself will cost \$25,000.

The C.A.R.E. Center has committed to raise the funds for the trailer renovation. Renovation monies must be raised by May 15, 2005, to reach the target goal of June 30, 2005, for installation of equipment.

The clinic is set to open in the fall of 2005.



## NHTC Board establishes policy for advertising in its member magazine, *The Communicator*

#### NHTC ADVERTISING POLICY

April 1, 2005

NHTC publishes the monthly magazine *The Communicator*, with two primary goals in mind:

- 1) Keeping our members informed about news and events affecting their Cooperative, while passing along information about NHTC's services; and
- 2) Providing our service area with a means of circulating community news and features among the Cooperative's membership.

By opening the magazine to advertising, both goals are advanced:

- 1) Revenue from advertising sales helps fund NHTC's efforts to keep its members informed; and
- 2) Members are presented with information on local purchasing opportunities, while member merchants are given access to cost-effective advertising opportunities to sustain and grow their business.

In an effort to ensure a sound, fair and reasonable execution of our advertising program, the following guidelines will apply to all advertising in *The Communicator*.

- 1) Ads will be accepted from members of NHTC only. At this time, advertising opportunities are not available to anyone who is not a member of NHTC.
- 2) All ads submitted for publication must be professionally designed and appealing; NHTC staff and representatives will assist with ad development at no additional cost to members.
- 3) No ad will be accepted for publication that contains vulgar, lewd, obscene or otherwise inappropriate or objectionable text or images.
- 4) NHTC reserves the right to refuse to publish any ad for any reason, based on the best interest of the magazine and its service to the public.
- 5) Advertising in *The Communicator* will be open to all members as space is available, on a first-come first-serve basis. Each issue of the magazine will feature a limited amount of advertising space; as a result, there is a possibility that some advertisers may not be able to place their ads in the desired issue. NHTC will make every reasonable effort to accommodate all appropriate ads.
- 6) Types of advertising accepted for publication in *The Communicator* (provided they meet the guidelines mentioned above) include, but are not limited to:
  - A) Promotions
  - B) Product and service sales
  - C) General business information
  - D) Political (with proper disclaimers as required by law)
- 7) At this time, advertising opportunities are not open to classified ads and personal listings, or to anyone who is not a member of NHTC.
- 8) In regard to advertising opportunities, NHTC does not discriminate on the basis of race, religion, gender or national origin.
- 9) While requests will be considered, NHTC cannot guarantee that ads will be placed on a particular page or in a particular order. Placement is at the sole discretion of NHTC staff and representatives.
- 10) NHTC reserves the right to revise these guidelines at any time. Members will be notified, either by mail or through the pages of *The Communicator*, in the event such revisions are made.
- 11) NHTC staff and representatives will develop and maintain a schedule of advertising rates that will apply to all advertising sales. This rate schedule will include discount incentives for multiple-issue contracts. Special pricing packages may be made available on occasion as part of one-time promotional opportunities.

#### Students rank high on reading test

Each year, students in Kindergarten through fourth grade take a reading test given by the state of Alabama. The DIBELS (Dynamic Indicators of Basic Early Literacy Skills) test is given three times each school year. After the midyear report, New Hope Elementary learned that its students ranked 45th

overall out of 719 schools included in the report.

#### Gardening and landscaping can help you stay fit



#### **Ouick Trick Clam Chowder**

Great for "pop-in" company

1 pkg. scalloped potatoes

1 can (7-8 oz.) minced clams (reserve liquid)

1 Tbsp. shredded green onion

1 Tbsp. green pepper

1-1/2 c. milk

1 Tbsp. butter

In large saucepan, mix potato slices, sauce mix, amount of water and milk called for on the package, clam liquid, green onions and green pepper. Heat to boiling, stirring occasionally. Reduce heat. Cover and simmer about 25 minutes or until potatoes are tender, stirring occasionally. Stir in clams, 2-1/2 c. milk and butter. Heat through. Serve with cornbread muffins. Recipe can be doubled or tripled and frozen.

#### Chicken & Ham Supreme

For special occasions

6 whole chicken breasts, boned, halved 1/4 c. margarine 1/4 tsp. pepper 2 c. chopped onions 1 c. dry Sherry 1/4 c. cornstarch 4 c. milk

3 c. water

12 slices Swiss cheese

1/2 tsp. salt

12 chicken bouillon cubes

12 slices boiled ham

1 lb. 8 oz. spaghetti cooked 8 mins. & drained

In Dutch oven, brown chicken a few

pieces at a time in margarine over medium heat for 15 minutes or until tender. Remove chicken, add onions and cook 5 minutes. Mix cornstarch, salt & pepper. Gradually stir in Sherry until smooth. Add to onions with milk, water, bouillon cubes stirring constantly. Bring to boil over medium heat. Boil one minute. Grease 6 qt. shallow baking pan or two 3 qt. casserole dishes. Add spaghetti and pour on sauce, then toss. Roll cheese inside ham. Arrange ham rolls with chicken over spaghetti. Bake tightly covered in 325° oven for 45 to 60 minutes or until hot. Makes 12 servings.

#### California Amaretto Cake

Frequently requested by friends & family

4 eggs

1 pkg. two-layer yellow cake mix

1 pkg. (3-3/4 oz.) lemon-flavored instant pudding mix

2 Tbsp. Amaretto

1/2 c. vegetable oil

1/2 c. plus 2 Tbsp. water

Beat eggs until light. Add cake mix, pudding, Amaretto, water & oil. Beat for 10 minutes. Pour into greased and floured 10-inch tube or bundt pan. Bake in 350° oven for 50 minutes. Cool in pan. (Do not invert pan while cooling.) Remove from pan and glaze.

Glaze:

2 c. confectioner's sugar

2 Tbsp. orange juice

2 Tbsp. Amaretto

1 Tbsp. grated orange rind About 2 Tbsp. additional Amaretto,

if glaze is too thick

Orange peel twists and sliced almonds

Combine first 3 ingredients in the saucepan and heat just until boiling. Stir in orange rind. Cool. Gradually stir in 2 Tbsp. Amaretto, or just enough to make glaze soft enough to drizzle over the cake. Garnish with twists of orange peel and almonds.


